British Council/Newton Fund - Institutional Links Grants 2017

Descrição

The [Institutional Links Grants](#) provide small-scale seed funding for collaborations between the UK and the participating Newton Fund countries. The Programme is designed to be flexible and responsive to in-country needs, allowing applicants to establish collaborations on specific areas linked to country priorities and development needs, and to bring in relevant private and third sector partners, including small and medium enterprises (SMEs), non-governmental organisations (NGOs), technology transfer offices, and other not-for-profit organisations.

June 13, 2017, 16.00 (UK time).

Elegibilidade

Each proposal must have one Principal Applicant from the UK and one Principal Applicant from the partner country (Brazil, Egypt, Indonesia, Kenya, Malaysia, Mexico, Philippines, and Thailand).

Both Principal Applicants must be Leading Researchers or Established Researchers.

Principal Applicants must be permanent employees of one of the following (this means that Emeritus and Honorary Professors may not apply as lead):

1. A not-for-profit higher education institution with the capacity to undertake high-quality research, unless specified otherwise in [Appendix 1](#) (page 14);
2. A UK higher education institution (all UK higher education institutions are eligible);
3. A not-for-profit research organisation with the capacity to undertake high-quality research
A Catapult Centre (in the case of the UK Principal Applicant).

Both of the Principal Applicants' institutions (the Lead Institutions) must have the capacity to administer the grant.

Valor Financiado

Up to £120,000.00 overall. The UK institution may request a maximum of £60,000.00.

British Council/Newton Fund - Researcher Links: Workshop Grants 2017

Descrição

The [Researcher Links: Workshop Grants](#) supported by UK government and partner country funding and forms part of the Newton Fund are designed to provide financial support to bring together a UK/partner country bilateral cohort of early career researchers to take part in workshops to meet the overarching objectives.

The Grants are intended to support research areas relevant to the development of partner countries, such as:

1. Agriculture (irrigation, crop yields);
2. Climate and environment (climate change, green technology, sustainable development, ecosystem services, resource scarcity);
3. Sustainable energy for all;
4. Education research for development;
5. Economic growth (equitable growth, financial sector development, private sector development);
6. Health (HIV/AIDS, malaria, tuberculosis, neglected tropical diseases, child mortality, maternal health);
7. Water and sanitation;
8. Food and nutrition (including food security);
9. Demographic change and migration;
10. Rural and urban development;

11. Infrastructure (including civil engineering, information and communication technologies, big data for social and economic development);
12. Humanitarian disasters and emergencies, disaster risk reduction;
13. Resilient and connected communities;
14. Governance, society and conflict (transparency, accountability, effective institutions, land and natural resource rights, poverty alleviation, social development, structural inequalities, violence and security, peace building, civil society);
15. Development-relevant data collection, quality and access (including administrative data and macroeconomic statistics).

Elegibilidade

Each proposal must have one Principal Applicant from the UK and one Principal Applicant from the partner country (Brazil, India, Kenya, Malaysia, South Africa, Thailand, and Vietnam).

Both Principal Applicants must be Leading Researchers or Established Researchers.

Principal Applicants must be permanent employees of one of the following (this means that Emeritus and Honorary Professors may not apply as lead):

1. A not-for-profit higher education institution unless specified otherwise in [Appendix 1](#) (page 13);
2. A UK higher education institution (all UK higher education institutions are eligible);
3. A not-for-profit research organisation. A Catapult Centre (in the case of the UK Principal Applicant).

Both of the Principal Applicants' institutions (the Lead Institutions) must have the capacity to administer the grant where contracting requires.

Benefícios

The maximum amounts that can be requested in each budget category are:

1. International travel: £1,000.00;
2. Domestic travel: £350.00;
3. Subsistence costs per person per day: £60.00;
4. Event costs per person per day: £25.00;
5. Additional workshop costs: £2,200.00.

Descrição

The workshop [Theories, Strategies and Methodologies](#), a partnership between the University of Portsmouth and the Universidade Federal de Goiás (UFG), aims to explore novel theories, strategies and methods for re-naturing cities. Approximately forty academics from the UK and Brazil, most of which will be early career researchers, will participate in this four-day workshop. The workshop will enable researchers to learn from best practice, critically analyse benefits and pitfalls of case studies, and advance current theoretical and empirical knowledge. The workshop will also offer valuable insight on how academics, planners and policymakers can apply this knowledge to their cities and regions.

Elegibilidade

Applicants must:

1. Be Early Career Researcher (holding a PhD, or having equivalent research experience, and having up to ten years post-PhD research experience). PhD students who are at least in their third year may be eligible should places be available;
2. Have a research or academic position (a permanent post, research contract, or fellowship) at a recognised research institution either in the UK or in Brazil.

Benefícios

All travel and accommodation expenses will be covered by the Newton Fund Researcher Links Programme.

Confap/ERC - Call for Expression of Interest in the Framework of the Implementing Arrangement between the European Commission and the Brazilian National Council of State Funding Agencies to Provide Research Opportunities in Europe for Brazilian Researchers 2017

Descrição

The [Call for Expression of Interest Call in the Framework of the Implementing Arrangement between the European Commission and the Brazilian National Council of State Funding Agencies to Provide Research Opportunities in Europe for Brazilian Researchers](#) invites Brazilian active Postdoctoral Grantees from the State Funding Agencies (FAPs), from the Coordination for the Improvement of Higher Education Personnel (Capes) and from the National Council for Scientific and Technological Development (CNPq), to pursue research collaborations with Principal Investigators already supported through EU-funded European Research Council (ERC) grants.

Note: Principal Investigators holding ERC grants have expressed interest in hosting Brazilian researchers to contribute to their teams for short or longer periods (up to twelve months).

Data Limite

May 31, 2017.

Elegibilidade

Active Postdoctoral Grantees from the State Funding Agencies (FAPs), from the Coordination for the Improvement of Higher Education Personnel (Capes) and from the National Council for Scientific and Technological Development (CNPq).

Note: Brazilian researchers should, in first instance, contact their respective FAP in order to verify if specific additional eligibility criteria are requested.

Benefícios

Eligible cost categories include:

1. Subsistence costs on a *per diem* basis, or any other applicable modality of the Host Institution, in accordance with the applicable national law and any other rules or regulations applicable on the Host Institution, commensurate to the level of experience of the individual visiting researcher;
2. Any other eligible costs incurred during the visit of the Brazilian researchers that are directly related to the ERC-funded project.

The Brazilian State Funding Agencies linked to the selected Brazilian Researchers (from the State of Origin of the researchers - where they actively work) will provide support for travel expenses. In case of a longterm visit (six months or longer).

Note: Travel allowance for accompanying family may also be covered.

Forma de Solicitação

Brazilian researchers have to send to their respective FAPs their proposal, following agreements taken with the Principal Investigator holding the ERC grant and according to the orientations in [Item 4](#) (page 3).

Letters of Interest at the first stage and complete proposals at the second stage must be sent in electronic format, at the following email address confap.erc.ia@gmail.com.

Observações

Brazilian researchers have to contact the Principal Investigator holding the ERC grant of the project that is of interest and must reach with him an agreement on the possibility of joining his research team as well as jointly define a Work Plan and related conditions.

Scientific exchanges shall start in the second semester of 2017 and can be either performed on a more extended timeframe (lasting six to twelve months) or be divided in multiple and shorter visits, such as to perform joint experimentation or similar research activities.

Brazilian active Postdoctoral grantees from FAPs, Capes and CNPq will continue to receive their salaries and/or scholarship according to their institutional terms and conditions.

Rainforest Action Network - Protect-an-Acre Fund (PAA)

Descrição

The Rainforest Action Network (RAN) campaigns for the forests, their inhabitants and the natural systems that sustain life by transforming the global marketplace through education,

grassroots organizing, and non-violent direct action. RAN aims to provide crucial and rapid funding for people fighting in their own communities across the globe to protect millions of acres of forest, to keep millions of tons of carbon in the ground, and to protect the rights and self determination of local communities.

The [Protect-an-Acre Fund \(PAA\)](#) was established in 1993 to protect the world's forests and support the rights of their inhabitants through small grants to traditionally under-funded organizations and communities in forest regions. PAA is a grassroots alternative to buy-an-acre programs that seek to provide rainforest protection by buying tracts of land, but which often fail to address the needs or rights of local Indigenous peoples.

Data Limite

Applications can be submitted at any time.

Elegibilidade

Top priority is given to:

1. Projects emphasizing grassroots organizing, education, training and capacity building to develop skills, increase awareness and/or build alliances towards protection of forests and increased community control over local resources;
2. Projects emphasizing community-driven, strategic use of non-violent direct action that supports local resistance to destructive development activities such as logging, oil extraction, dam construction and the expansion of monoculture plantations;
3. Projects supporting Indigenous communities securing or maintaining legal land title recognition (demarcation of territory, GPS mapping, resource inventories and management plans, meetings with neighboring communities).

Also supported:

1. Environmentally and socially sound sustainable economic alternative initiatives;
2. Travel and other opportunities that amplify community voices in regional, national and international forums and provide access to decision makers;
3. Field studies and original research used to hold companies accountable for their on-the-ground activities;
4. Seed money for emerging grassroots organizations.

Valor Financiado

Activities would be significantly enhanced by a small grant/applicant's annual budget (under US\$150,000.00 is prioritized), overall access to resources and previous funding from RAN.

Note: Grants generally do not exceed US\$5,000.00.

PAA does not support individual, governmental, or exclusively academic projects.

Rainforest Action Network - Climate Action Fund (CAF)

Descrição

The Rainforest Action Network (RAN) campaigns for the forests, their inhabitants and the natural systems that sustain life by transforming the global marketplace through education, grassroots organizing, and non-violent direct action. RAN aims to provide crucial and rapid funding for people fighting in their own communities across the globe to protect millions of acres of forest, to keep millions of tons of carbon in the ground, and to protect the rights and self determination of local communities.

The [Climate Action Fund \(CAF\)](#) was established in 2009 to award small grants to frontline community groups that are fighting to prevent fossil fuels from being extracted and/or the construction of large point sources of greenhouse gas emissions. CAF is a grassroots alternative to carbon offset programs.

Note: Instead of purchasing carbon credits, funds will be used to empower frontline communities to keep fossil fuels in the ground where they belong.

Data Limite

Applications can be submitted at any time.

Elegibilidade

Project must fit one of two basic categories:

1. Local resistance by frontline and impacted communities to prevent the extraction of fossil fuels such as coal, tar sands, oil and gas;
2. Local resistance by frontline and impacted communities to decommission or to prevent the construction of large point sources of greenhouse gas emissions (a large point source is defined as any source larger than 100,000 tons of CO₂).

Note: Project must involve community organizing and mobilization as a major strategy towards achieving its goal/ the community where the project is centered and/or that will be impacted by the initiative is engaged in the decision-making process related to the activities.

Valor Financiado

Activities would be significantly enhanced by a small grant/applicant's annual budget (under US\$150,000.00 is prioritized), overall access to resources and previous funding from RAN.

Note: Grants generally do not exceed US\$2,500.00.

CAF does not support individual, governmental, or exclusively academic projects.
