Atlas Corps Fellowship USA

Descrição

Atlas Service Corps, Inc. (Atlas Corps), started in 2006, is an international network of nonprofit leaders and organizations that promotes innovation, cooperation, and solutions to address the world's 21st century challenges. Its mission is to address critical social issues by developing leaders, strengthening organizations, and promoting innovation through an overseas fellowship of skilled nonprofit professionals.

The [Atlas Corps Fellowship USA](#) lasts six to eighteen months and is offered three times a year. Fellows serve full-time at [Host Organizations](#), develop leadership skills, and learn nonprofit best practices through the Atlas Corps Global Leadership Lab professional development series and networking opportunities with other Fellows who are skilled nonprofit professionals from around the world.

Data Limite

Atlas Corps considers applications on a rolling basis for its classes that begin in January, May, and September. Applicants are encouraged to apply by:

March 22, to be considered for September class;
July 15, to be considered for the January class;
November 8, to be considered for May class.

AvH - German Chancellor Fellowship for Tomorrow's Leaders 2017

Descrição

The Alexander von Humboldt Foundation (AvH) promotes academic cooperation between excellent scientists and scholars from abroad and from Germany.

The [German Chancellor Fellowship for Tomorrow's Leaders](#) is targeted at university graduates from the United States, the Russian Federation, the People's Republic of China, Brazil and India who have an international outlook and initial leadership experience. It addresses prospective decision-makers, multipliers and thought leaders from a broad range of professional fields such as politics, public administration and business as well as society and culture. The fellowships give them the opportunity to spend a year in Germany networking with other prospective leaders from abroad, who are also sponsored by the Humboldt Foundation, and to explore new solutions to the global issues.

Note: The AvH grants up to fifty fellowships every year - up to ten of which go to prospective leaders from each of the five countries.

6. Extensive alumni sponsorship after the stay in Germany has been completed successfully, in particular, to promote networking with the collaborative partners in Germany during the alumni's entire professional careers.

1. International travel expenses: by the most direct, economical route, from the beneficiary's country to and from Poland;
